



## **SOCIAL MEMBERSHIP 2024**

Thank you for your enquiry regarding Social Membership. The following information may be varied by the Board of Management at its discretion and is intended to provide a brief overview of the Club together with costs for Social Membership.

Puttenham Golf Club is a private Members' Club. It has standards of behaviour, etiquette and dress which have been set in order to create an atmosphere of conviviality, relaxation and friendliness. It is important to understand these standards and therefore what is expected of each and every member who joins this Club.

The annual subscription for Social Membership of Puttenham Golf Club in 2024. is £70 inclusive of VAT. There is no Entrance Fee payable for Social Membership. A Social Member is entitled to use both the Clubhouse and Practice facilities at no extra charge (purchase of range balls still apply).

The Clubhouse facilities include a welcoming Main Lounge, Spikes Bar, Dining Room and large Patio area, all of which can be enjoyed by Golfing and Social Members alike. Puttenham has always been known as a very sociable Club and Social Members are encouraged to attend the regular events such as Quiz or Bingo nights, Dinner Dance, Midsummer party, Bridge evenings and Sunday Lunches. Social Members may be issued with a bar card which, when "topped up" by £125 at the time of joining and renewal, can be used to purchase both drinks and food at a special member's discount rate. Puttenham offers a varied bar menu of delicious home-cooked food, freshly prepared on a daily basis. Social Members are able to introduce guests into the Clubhouse and may also hire the premises for a private social event (subject to certain terms and conditions).

The practice facilities include a large putting green and driving range, with ball tokens for the driving range available to purchase at the prevailing member's cost in the professional's shop. Social Members may book golf lessons with the Club Professional, who can also offer club hire if required.
