The meeting was called to discuss the question of the advisability of certain suggested alterations to the Gents Lavatory in order to enlarge the Bay in the Smoke Room.

The whole question was discussed and many suggestions were made by various members and it was finally decided to leave the Gents Lavatory as arranged on the plan.

It was then suggested that a great improvement might be made by extending the Bay in the Smoke Room towards the front of the building and the Architect stated that the extension would cost £30.

It was then unanimously decided that if the cost did not exceed the amount stated, the extension be carried out.

It was also decided that providing the cost did not exceed £30 the Architect be empowered to proceed with the extension without further meeting of the Committee.
