## Committee Meeting Thursday Oct 16th 1924.

Minutes of last meeting were read and confirmed.

The Secretary reported that the shafts for the hired cart had been broken, and that he was making arrangements for replacing same, this was approved.

The Secretary reported that the drainage from Gledhills farm was offensive and running right across No 3 Fairway, also that water ran from Gledhill's home field out onto No 4 Approach. It was decided that the Secretary write Gledhill asking him to take steps to abate the nuisance.

The question of poultry trespassing on the Course was discussed and it was decided that the Secretary obtain all the names of the owners and write them giving final notice prior to action.
