

MINUTES OF GENERAL COMMITTEE MEETING HELD IN THE CLUB HOUSE

ON THURSDAY, JULY 19th, 1973

Apologies for absence were received from the President (W.O.Bolt) and Mr. C.W.Cooper.

The Minutes of the previous Committee Meeting were read and approved.

MATTERS ARISING: The Captain congratulated Mr.Roberts and Mr.Heap on their work of laying the new piping for water to the Greens.

GREENS COMMITTEE: It was decided that the decision on when to play the new Course be left in abeyance until September.

Equipment Shed: It was Agreed that the Treasurer and Secretary would see the Borough Surveyor regarding the various possibilities.

Torro Greenmaster 3: Delivered price of the machine complete with spare reel and thatching kit is £2,396.00. Rental costs for 3 years; £850 per annum and 4 years at £42.30 per annum.

Hire purchase costs would be investigated.

It was Agreed that this Machine be obtained and the method of payment be decided by the Captain, Treasurer and Secretary. Agreed that the Service Contract offered, be accepted.
