Minutes of a General Committee Meeting held at the Club on Thursday June 21st 1956.

The Captain (Mr W O Bolt) presided.

Minutes of Handicap Committee were read and accepted as a true record.

Minutes of House Committee were read and accepted as a true record.

Minutes of Greens Committee were read and accepted as a true record.

Minutes of General Committee were read and accepted as a true record.

Owing to illness, Mr Cowan (Steward) was granted permission to terminate his services on 25/6/56. The Stock would be taken by the House Secretary (Mr Cawthron) at 11 a.m.

Mr Cowan's resignation was tendered owing to ill health and the Committee were very sorry to lose such a valued servant.

It was decided to present Mr & Mrs Cowan with a cheque for £10 as a token of esteem for the good work they had done for the Club. It was also agreed to buy the Piano for £15 and also a Hoover Polisher for £15.

No reply had been received from the Waterworks Committee respecting the tenancy of Land at Hazelhurst about which a deputation met them at the Town Hall Chambers.

It was left to the Captain and Secretary to interview Mrs Osborn respecting her acceptance of the position of temporary Bar Stewardess until the arrival of Mr & Mrs Clift. The Hours she

Miss B Smiths resignation was accepted with regret.

Application for Country Membership of Mr G Symington and Mr B Ellis were accepted subject to confirmation by the Secretary. Application from Mr D J Greenhough for Social Membership was accepted.

A request from the Ladies Committee for installation of a Hot Water Geyzer in the Ladies Locker Room was declined owing to prohibitive cost of Fuel and Lighting. The Committee being very alarmed and concerned regarding same. At the present time we are having an enquiry made by the North West ~~Coal~~ Gas Board as to the most economical way of heating the Club.

It was left to the Secretary to see Mr R Wood respecting the letter from the Insurance Company regarding the liability for the smashed electric clock.
