The Secretary reported receipt of a letter from the Post Office Telephone Sales Manager regarding application for extension of telephone to the Professional's Shop and intimating that at the present time such an extension is entirely impractical.

A letter was read from M<sup>r</sup> H Crowther respecting practicing on the day or days of a Stroke Competition and the Committee being of the opinion that it was impractical to define an area on which competitors may practice, it was decided that we adhere to the Rules of Golf.

The Meeting closed with a hearty vote of thanks to the Captain for presiding.
