## Special General Committe Meeting May 26th 1922

Present: Reg Whitworth in the Chair. Mess<sup>rs</sup> H Slatter, W C Morris, A Morris, J H Taylor, J Lochead, G, F L Eaton, W H Andrew, A Lees and J Gibson.

It was decided that "if suitable for the Ladies" that the day for the Mixed Running Foursomes Competition be altered from Tuesdays to Fridays. M<sup>r</sup> Whitworth introduced the question of a match between members of the Dental Profession and members and it was decided that such a match be arranged for some Tuesday evening.

In respect of the offer of M<sup>r</sup> Fred Moss to arrange with some professional at his own expense; the Club to find the other player to take part in a match. It was decided that such a match be arranged; M<sup>r</sup> Moss and the members to <del>charge and</del> be responsible for the finances: that the match be fixed for some evening and all arrangements be left to the Handicap Committee.

It was stated that the Ladies Captain wished to know if the Cup presented by her was covered by insurance, and it was decided that the question of insurance be looked up by the Secretary.

The Handicap Committee reported several alterations to handicaps and these were accepted.

M<sup>r</sup> Slatter introduced the question of scorecards being marked by members who had not themselves a handicap. It was decided to leave the matter in the hands of the Handicap Committee.

The House Committee reported that they had met on two occasions in respect of the Tariff question; at the first meeting the prices were considered after which M<sup>r</sup> & M<sup>rs</sup> Butcher were instructed to prepare a revised list for the Committee's approval; instead of doing this, the prices were reduced and the quantities cut down to such an extent as to give general dissatisfaction. The Committee again met and considered changes along with M<sup>rs</sup> Butcher who agreed to certain reductions in price, she also stated that she was prepared to increase the quantities. M<sup>rs</sup> Butcher however expressed so much dissatisfaction with the Committee and conduct of several of the members, although she would give no names, that the House Secretary finally decided to recommend to the General Committee that M<sup>r</sup> & M<sup>rs</sup> Butcher be given a month's notice to terminate their services. After considerable discussion it was moved by W C Morris, seconded by J Gibson that the House Committee's recommendation be adopted. An amendment was moved by W H Andrew, seconded by J Lochead that M<sup>r</sup> & M<sup>rs</sup> Butcher, "owing to the differences which had arisen" be asked to resign within seven days. Seven member voted for the Amendment and the following voted for the recommendation of the House Committee. W C Morris, F L Eaton, Reg Whitworth and J Gibson. The amendment was duly carried.
