

General Committee Meeting Thurs April 10th 1930.

The Minutes of last meeting were read and passed.
It was reported that M^r Payne's Club had been found.

The following transfers from playing members to honorary members were agreed to: - M^r Fred Orford, M^{rs} F Crossley and M^{rs} P C Firth.

A discussion took place regarding the decrease in membership and M^r Andrew was asked to consider the question of bringing to the Notice of the Public that new members were required.
