

Annual General Meeting of Members May 7th 1921

M^r H Slatter presided and 40 members were present.

The Minutes of last Autumn Annual Meeting were read and adopted.

The Financial Statement was considered and after being explained by the Treasurer, M^r Ja^s Lohead, it was moved by M^r Ja^s Kershaw that the Balance Sheet be adopted, seconded by M^r F Moss and carried unanimously. M^r Ja^s Kershaw in moving the adoption of the Balance Sheet referred to the considerable amount of work done by M^r Lohead, also the House Committee and stated that on behalf of the Auditors he had pleasure in saying that they found the Accounts in proper order.

The Secretary's Report for the Year was read giving particulars of the work done by the Committee and Sub-Committees, also the position of the Club as regards membership etc. also reference to the Levy being unsatisfactory. It was moved and seconded and that the Secretary be thanked for same. (Carried unanimously).

The recommendation of the Committee that the Club provide mementos for the winners of the Hall Cup and War Trophy was discussed and the motion of M^r H Slatter seconded by M^r Widdop and supported by M^r Ja^s Kershaw this was agreed.

Several suggestions as to the form of memento were made but it was decided to leave the question in the hands of the Committee.

The President, M^r J W Kenworthy, being unable to attend, the presentation of the Kenworthy Cup replica and Lady Aitken Cup memento did not take place.

The Captain, Mr H Slatter presented the prizes "given by M^r A Smith" to the winners of the Men's Foursomes Competition which had taken place that day.

Mr Hall introduced the question of the Subscription from the Officers Mess vi:- £10/10/- and stated that he thought this amount inadequate, several members took part in the discussion which followed and eventually it was decided to leave the matter in the hands of the Committee for serious consideration.

The question of the Levy was discussed by several members, also the Subscription, but the matter was left over until the Autumn Meeting.

M^r Jo^s H Taylor gave notice of motion that at the next Annual Autumn Meeting he should move that the subscriptions be increased to £4/4/- for Gentlemen and £2-2-0 for Ladies.

A vote of thanks to the Auditors moved by M^r J R Widdop, seconded by M^r A Lees and supported by M^r Jas Lohead was carried unanimously, and M^r Jas Kershaw accepted same on behalf of the Auditors.

A vote of thanks was given to the Captain for his Services, proposed by M^r E Williamson seconded by M^r J H Taylor and supported by M^r W H Andrew; and M^r Slatter suitably acknowledged, and replied to the great assistance he had received from the Committee and members of the Club.

A hearty vote of thanks to all the donors of prizes was given, moved by M^r F Moss seconded by M^r J Smethurst.

A vote of thanks to the Captain for presiding terminated the meeting.
