

COMMITTEE MEETING
Held Monday, 11th April, 1960.

Present: In the Chair the ex-Captain H. Greaves and eight members of the Committee, Messrs. Baxendale, Bolt, Broadbent, Broucher, Buckley, Lees, Plant, the treasurer and the secretary.

HANDICAP COMMITTEE.

The minutes of the meeting were read and approved.

GREENS COMMITTEE

The minutes of the previous meeting were read and approved.

It was agreed that the Greens Committee, along with the professional and the greenkeeper should get out a programme for the mowing of the fairways and semi-rough.

R. Lees moved and J. Buckley seconded, that in regard to the area in the channel running down to the hollow in front of the 8th green, which is enclosed by a whitewashed line, "when a ball arrives inside this area it must be played off a tee peg".

R. Lees proposed and W.O. Bolt seconded that the competition 2nd tee be used as a temporary and experimental measure by members of the committee when playing the 17th.

It was agreed that E. Brooks be allowed to buy a new wheelbarrow.

Brooks reported that the new boy Hurst, who commenced on April 4th, 1960 at £6.16.0. per week, was progressing satisfactorily, and would later be able to drive the tractor and use the power mowers.

R. Lees proposed and J. Buckley seconded that Quick's service offer of 9 services in 12 months, at a set figure, be accepted.
