The Meeting was called to discuss the position arising from the death of Mr. F. Cowan the steward. After discussion it was agreed to offer the position of stewardess to Mrs. Cowan at a salary in accordance with the Hotel and Catering regulations of £7.10.0 plus 10/0d to cover services of waitress.
