The Secretary reported that the Junior section was in grave danger of folding up due to lack of interest. It was

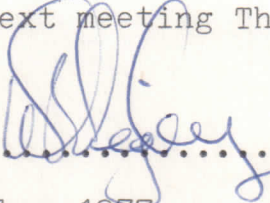
