

MINUTES OF GENERAL COMMITTEE MEETING HELD IN THE CLUB HOUSE ON
THURSDAY, 8th. DECEMBER 1966.

- PRESENT:** The Captain (F.J. Rowley) in the Chair, Messrs. Lewis, Clegg, Jones, Hartley, Fiddian, Meeks, Robinson, Howard, Hitchen, High, Butlin, and Stephenson.
- Apologies for absence was received from H. Hopkinson.
- The minutes of the previous meeting were read and approved, as were those of the special meeting.
- MATTERS ARISING:** The committee were give a report by the Captain and the ex.Captain, on their visit to the President on 5th. December, when they took the present from the Club, together with an address of appreciation and Life Membership, on the occasion of his Golden Wedding Anniversary.
- Both stated how surprised and delighted Mr. & Mrs. Wood were to receive their gift, particularly as they had contrived to keep secret this special event. In accepting the honour of Life Membership, the President intimated that whilst he very much appreciated the honour conferred upon him, he would still continue to pay his annual subscription as always.

- CORRESPONDENCE:** The Clayton Aniline Golfing Society were granted permission to play on the course, subject to the usual conditions appertaining at the time, on Friday Evening, 9th. June 1967.
- ANY OTHER BUSINESS:** It was agreed to confer the honour of Life Membership on Mrs. G. Swallow and Mrs. R. Wood in January next year. The Lady Captain would be given suitable letters to each of these ladies, so that she might deliver same when making the announcement at their Annual General Meeting.
