

General Committee Meeting Thursday Oct 11th 34.

Present: E Raines in the Chair.

Mess^{rs} G Robson, H L Boardman, Ja^s Kershaw, R Bennett, H Ridyard, J Taylor, J H Barratt, Syd. Hall, R Wood, E S Jones, W H Andrew and J Gibson.

The Minutes of last meeting held September 13th were read and adopted.

Miss M Hilton was duly elected a lady member of the Club by ballot.

The following accounts were passed for payment: - Scott & Sons 5/2/7, Williamson & Ball 4/8/9, Taylor & Fothergill 4/6/8, J Andrew & Co 1/13/6, J W Hall Ltd 2/10/- C H Bowler 14/8/-, Geo. Makin & Sons Ltd 5/-/-, Ja^s Ridyard & Sons 16/10/-, S Sidebottom Ltd 8/6/68. Total £62-6-2.

It was decided that the whole of the members of the General Committee shall be members of all Sub-Committees, viz: - House, Handicaps, Greens and Finance.

The following were appointed Secretaries to the sub-committees: J H Barratt, House & Shop: H Ridyard, Handicap: J Gibson, Greens also Finance.

The following were appointed to serve on the Social Committee. Messrs W H Andrew, E S Jones, Syd. Hall and J Taylor as Secretary with the Captain as ex-officio.

Several suggestions made at the Annual Meeting were considered viz: -

Question of having an Annual Supper. Extending the Course or Making provision in the event of land being taken for building. Luxor Cup Competition might be made into an Open Invitation. Bunkering the Course. Presentation of prizes on the day they are won and question of prizes being handed over by the Steward. Also provision of hot meals or drinks after 6.30 on Sundays during the ~~Winter~~ Summer.

Extending the Course: It was decided that this could not be dealt with at present, and in any case we cannot say definitely which land might be required, and cannot therefore make arrangements.

It was decided to hold a Supper on Tuesday Nov 20th. charge to be 2/6 per head, but not necessarily an Annual Event.

In regard to the Luxor Cup Competition it was decided not to alter this event as it was thought to be inadvisable, also that no "Open Invitation" be arranged for next season as it was considered that it would only meet with the wishes of the few.

The question of Bunkering had been considered by the Greens Committee and it was generally agreed that any scheme of bunkering should be mapped out under expert advice and owing to the possibility of land being taken for building, it was deemed inadvisable to undertake this work at present.

In regard to the question of presenting prizes, the Committee considered that the system now in vogue is quite satisfactory and in the case of the winner of a prize leaving the premises before the result is known, such prize would be handed to the Steward for handing over.

It was decided to adhere to the arrangement that hot meals or drinks shall not be provided by the Steward after 6-30 p.m. on Sundays during Summer.

The Minutes of the House, Handicap and Greens Committees were passed as read.
