## MINUTES OF THE SPECIAL COMMITTEE MEETING HELD IN THE CLUB HOUSE ON THURSDAY 23<sup>rd</sup>. MARCH 1967.

PRESENT:

The Captain (R.H. Meeks) in the Chair, Messrs. Robinson, J. Meeks, Fiddian, Hartley, A. Howard, Sykes, Rowley, N. Howard, Hopkinson, High, Butlin and Stephenson.

In opening the meeting, the Captain, stated that he had asked for this meeting in order to confirm the Sub-Committee's recommendation to accept the quotation of En-Tout-Cas, for the draining and seeding the ground leading into the new area of the course. Furthermore, the question of the car park could be fully discussed and the admission of new members considered.

En-Tout-Cas:

It was unanimously agreed to accept the quotation received from En-Tout-Cas, to drain, grade, cultivate and seed the area needed to join the present 8<sup>th</sup>. Fairway to the new ground already made so making the Fairway at this hole continuous. Also at the same time they are to provide and lay 50 yds. of

4" drain pipes between the present 9<sup>th</sup>. and 10<sup>th</sup>. Fairways and mole drain approximately 1½ acres of this area at 2'6" centres. The whole of the work to be completed by the end of April this year.

The cost for this work as quoted will be as follows:

Draining, grading, cultivating and seeding the 8<sup>th</sup>. Fairway £832.

Laying drains between old 9<sup>th</sup> and 10<sup>th</sup>. £37.10.0. Mole draining at 2'6" centres £48. per acre.

All works to be carried out to our satisfaction as per contract number 87066,

dated 20<sup>th</sup>. March 1967.

CAR PARK: After much discussion, it was agreed to shelve the question of

Tar-macadaming the car park for the present, but some programme of

gradually doing this work would be considered during the year.

OLD PUTTING GREEN: Various schemes for utilizing this ground were examined and no decision was

arrived at, but members were asked to consider the possibilities of either making it an extention (sic) to the car park or remaking it into a putting green.

Time would be allotted at the next meeting for further discussion.

HEAD GREENKEEPER: It was unanimously agreed to accept the Sub-Committee's recommendation

that we engage A. Fielding as our Head Greenkeeper, at a wage of £20 per week. He is to commence his duties as soon as possible, which it is expected will be in one months time. The Secretary was instructed to see Fielding and

confirm the appointment.
