It had been noticed that F. Cooper for a number of years, had pruned the roses in front of the Club House, this was a self imposed task and the Committee instructed the Secretary to write and convey their appreciation.

STEWARD'S WAGES:

Hartley), and owing to the rise in living costs, it was agreed to increase the joint wage of Mr. & Mrs. Milroy by £1.0.0d. per week, commencing the first pay day in June. In addition they would receive half the total surplus in Bar Takings to the end of the year, the year end being the 31st. December.

The Secretary was instructed to write to the C.W.S Golfing Society complaining of their conduct during a recent visit.

ANY OTHER BUSINESS:

Replying to a question the Secretary stated that along with G. High he had approached the farmer E. Wrigley with regard to obtaining still more ground.

The interview was long and on a very friendly basis, however Mr. Wrigley adamant in his attitude that he required all the land he had at the present time, although should the position change at any time, he promised to notify us immediately.

There being no further business, the meeting closed with a vote of thanks to the Captain for presiding.
