

Committee Meeting March 10th 1922

Present: Reg Whitworth in the chair.

The Minutes of last meeting read and confirmed.

The following, duly nominated and seconded were passed for membership:- M^r P Tildsley, Carlton Road, Ashton, M^r & M^{rs} F W Mallalieu, Stockport Road, Ashton. Miss O Chadwick, Atlas Street, Waterloo, Ashton and Miss D Kershaw.

In reference to Miss D Kershaw's nomination, the form was filled in for Junior Membership, but the Committee decide to adhere to the former resolution, not to admit Junior members at present.

The Report of the Handicap Committee was accepted.

A letter from the Superintendent of the Salford Royal Hospital was read in relation to a proposed competition to raise funds. It was decided that the letter lie on the table.

The question of the runner up prize in the Kenworthy Cup Competition for last Season was introduced by Reg Whitworth. The prize was promised by H Lane who up to the present had not fulfilled his promise or taken any notice of communications in respect to same.

The question of unemployment insurance for Groundsmen and the recent decision in the Courts was introduced by J Gibson who stated that it was now unnecessary to pay such insurance and that all monies paid in respect to same could be recovered by making application through the Employment Exchange. It was decided that M^r Lohead go into the question and find out the amounts paid, so that the question can be discussed at the next meeting and in the meantime to cease payment or stamping the cards in respect of unemployment of Groundsmen.
