



MUNDESLEY GOLF CLUB Limited – Club Rules

Terms and Conditions of Membership

Mundesley Golf Club may change the Terms and Conditions from time to time but will post changes on our website and members will be notified by email and post where email is not possible. Members are respectfully reminded of their obligation to observe all Club rules and conditions set out in the Club's Articles of Association, and other rules as set by the Directors of the Club from time to time. You can use the Club facilities in accordance with your membership category.

1.0 Application for Membership

All prospective members need to complete in full a Membership Application Form. Acceptance of Membership shall be at the sole discretion of Mundesley Golf Club Limited.

1.1 Amount

All Members must pay an annual Membership Fee, according to the category of Membership currently held. Mundesley Golf Club reserves the right to vary the Membership Fee in accordance with the Articles of Association. The fees, as well as any privileges and restrictions that may apply as to the use of the Club facilities shall be determined by the category of Membership purchased by the Member. Membership Fees and any additional charges are non-refundable. Membership Fees and charges are subject to review; all changes will be displayed on the Club noticeboard.

1.2 Membership Subscriptions

Members have a choice to pay their fees either in advance in full for the commitment period or monthly for selected categories through Direct Debit, allowing the Members to spread the full year's Membership Fee over the course of a 10-month period.

1.3 Accepted methods of payment

Membership subscription and fees can be paid via BACS transfer or by cash, cheque, and selected Debit/Credit cards in the Pro-Shop.

1.4 Direct Debit Payments

Direct Debit collections will take place on or just after the 1st of each month unless otherwise advised. Where the 1st of the month falls on a weekend or a bank-holiday, payment will be collected from the member's bank account on the first available banking day. Should the membership payments by Direct Debit instalments not be fulfilled, the outstanding balance of the subscription for the membership period will become immediately payable in full.

1.5 Direct Debit – New member Initial Payment

The Initial payment for new Direct Debit paying members wishing to pay by monthly Direct Debit includes the annual Golf Affiliation Fees (if applicable) and a first month of membership subscription.

1.6 Missed and Late Payments

Member status is maintained provided the Membership is current and fully paid-up, or payment arrangements acceptable to the Club have been agreed, otherwise access to the Club premises may be refused through suspension of membership or expulsion from the Club.

1.7 Direct Debit Rejections and Cancellations

Should a Direct Debit fail to be collected, the Member will be requested to make an online bank payment or visit the Shop or Office to settle the arrears within 10 working days.

2.0 MEMBERSHIP CONDITIONS

2.1 Contract and Club Rules

The Terms and Conditions form the principal Agreement between the Member and Mundesley Golf Club Limited. In signing the Application form, the Member is expected to comply with the Club Rules that are available on the Members' website or at the Club. The Company may sometimes need to make changes to the Club Rules. When changes occur, appropriate notices will be communicated by email and will be displayed in the Clubhouse notifying members of the change(s).

2.2 Termination of Membership

Golf membership may only be terminated on the annual renewal date, which falls on the joining date annually, or on an alternative date previously agreed.

2.3 Notification of Termination

Members must ensure that all termination requests are made in writing, in the form of a letter or email, by giving not less than one calendar months' notice.

2.4 Changes to Member Personal Details

Members must advise the Club immediately of any change to their personal details, including change of name, home address, e-mail address and contact telephone numbers.

3.0 MEMBERSHIP CATEGORIES

Full Membership

This category entitles the Member to access the Golf Course and all Clubhouse Facilities during opening hours throughout Monday to Sunday.

This category has full voting rights at AGM and other formal meetings of the club.

Members under this category are eligible to stand as officers for the club.

The option to pay by monthly Direct Debit is available.

Full Membership - Age categories 19-37 years inclusive

As Full Membership above.

OAP & 25 Years

As Full Membership above.

Members are entitled to apply for this category upon reaching the State Pension Age and having been a continuous member of the club for at least 25 years.

50 Years Plus

As Full Membership above.

Members are entitled to apply for this category upon reaching 50 years of continuous membership of the club.

Honorary Life

As Full Membership above.

The Board of Directors can nominate a member at a General Meeting for consideration granting Honorary Life membership.

Discretionary

As for Full Membership above.

The Board of Directors can agree at their sole discretion, and on an exception basis, special terms and conditions of membership for a Member for a period of 1 year.

5-Day Golf Membership

This category entitles the Member to access the golf course from Monday to Friday (excluding bank holidays), and all clubhouse facilities 7 days a week. On payment of the member guest round green fee prior to playing, a 5-Day Member may play on weekend days or on bank holidays, whether or not in formal club competition golf.

This category has full voting rights at AGM and other formal meetings of the club.

Members under this category are eligible to stand as officers for the club.

The option to pay by monthly Direct Debit is available.

9-Hole Membership

This category entitles the Member access to the golf course for 9 holes, once a day, and all Clubhouse Facilities, 7 days a week. On payment of the member guest 9-hole green fee ahead of playing more than 9 holes such a Member may play 18 holes on that day whether in formal club competition or non-club competition golf.

This category has full voting rights at AGM and other formal meetings of the club.

Members under this category are eligible to stand as officers for the club.

The option to pay by monthly Direct Debit is available.

Flexi/Points Membership

This category entitles the member to access the golf course and all Clubhouse Facilities Monday to Sunday conditional to the member maintaining a positive Points balance on their account. Each time a member plays on the course, points will be deducted from their Points balance in accordance with the Points Playing Matrix. Points balances cannot be rolled over into a new Membership year.

This category has no voting rights at AGM and other formal meetings of the club.
Members under this category are not eligible to stand as officers for the club.
The option to pay by monthly Direct Debit is not available.

7-Month Twilight Membership (closed for new applications)

This category entitles the Member access to the golf course between 1 April and 31 October of a calendar year after 1pm, and all Clubhouse Facilities, 7 days a week.

This category has no voting rights at AGM and other formal meetings of the club.
Members under this category are not eligible to stand as officers for the club.
The option to pay by monthly Direct Debit is not available.

Second Club Membership

Second Club Membership is available to those who are a Full Member (7-day/week without restrictions) at another Golf Club.

This category entitles the Member to access the golf course and all clubhouse facilities, 7 days a week.

This category has no voting rights at AGM and other formal meetings of the club.
Members under this category are not eligible to stand as officers for the club.
The option to pay by monthly Direct Debit is available.

Country Membership (Outside Norfolk)

This category entitles the Member to access the golf course and all clubhouse facilities, 7 days a week.

This category has no voting rights at AGM and other formal meetings of the club.
Members under this category are not eligible to stand as officers for the club.
The option to pay by monthly Direct Debit is available.

Trial Membership

Allows full access to the facilities, across 7 days, for 3 months from the joining date. Any member will only be allowed to apply for this category of membership once.

This category has no voting rights at AGM and other formal meetings of the club.
Members under this category are not eligible to stand as officers for the club.
The option to pay by monthly Direct Debit is not available.

Junior Membership - Under 18 Years of age on January 1st.

This category entitles the Member to access the golf course and all clubhouse facilities, 7 days a week.

This category has no voting rights at AGM and other formal meetings of the club.
Members under this category are not eligible to stand as officers for the club.
The option to pay by monthly Direct Debit is not available.

Junior Academy Membership – Under 18 Year of Age on January 1.

This category does not entitle the Member access to golf course but does entitle the member the use of club practice areas and clubhouse facilities, 7 days a week.

This category has no voting rights at AGM and other formal meetings of the club.
Members under this category are not eligible to stand as officers for the club.
The option to pay by monthly Direct Debit is not available.

Social Membership

Access to the facilities across all 7 days a week. Social Members are entitled to play 6 games at member guest rates, across their membership period.

This category has no voting rights at AGM and other formal meetings of the club.
Members under this category are eligible to stand as officers for the club.
The option to pay by monthly Direct Debit is not available.

Sponsor Membership

A Sponsor Membership can only be in the name of a single individual.

Access to the facilities will be as agreed in the individual sponsor agreement.

This category has full voting rights at AGM and other formal meetings of the club.
Members under this category are eligible to stand as officers for the club.
The option to pay by monthly Direct Debit is not available.

4.0 MUNDESLEY GOLF CLUB EPOS CARD

Qualifying members may be issued with a Club Electronic Point of Sale card (EPOS).

The issue of such a card is at the sole discretion of the Club.

The EPOS card enables members to deposit funds to their card and make (discounted and non-discounted) purchases in the Bar and Pro-Shop as well as enabling automatic charging of Competition entry fees.

It is the member's responsibility to maintain positive balances (Club and Pro-Shop) on their EPOS card. Any arrears need to be settled within a 14-day period.

The Club at its discretion can move funds between a member's Club and Pro-Shop EPOS balances to clear any arrears. The member will be informed of such a transaction.
