Membership Terms and Conditions

Election to membership

Election to membership of the Club, other than Life and Honorary members, shall be the responsibility of the General Committee.

Candidates for membership must be proposed by two Voting Members who have been Voting Members for at least eighteen months. The guidelines for the recruitment of new members shall be as outlined in the membership section of the Bye Laws.

Playing Rights

All members have the use of the Club premises and amenities at times in accordance with the Bye Laws.

Seven Day and Life members may enjoy unrestricted playing rights except when the course is officially closed or playing times restricted.

Five Day Plus and Five Day members may use the course for playing golf on all days except Saturdays and Sundays unless specially authorised by the General Committee.

Country members must be former members of the Club who cease to have a residential and/or business address within a 75-mile radius of the Club. Country members may use the course and play in those competitions for which they were eligible in their former membership category

Overseas members who have a permanent residence abroad may whilst in the United

Kingdom use the club facilities for a maximum of six months in any Club year. The annual subscription shall be as specified in Rule 7.1, with the proviso that should the stay exceed six months in a Club year and the member wishes to continue to use the Club they will be liable for the full year's subscription

Member Conduct

Any complaint about the conduct of a Club Member must be reported to the General Manager, in the first instance. If the matter cannot be resolved at this level it shall be submitted, in writing, to the Club Chairman who may invoke the Club's Disciplinary Procedure

In all cases where the suspension or expulsion of a Member is carried out or the Member chooses to resign, such Member shall have no remedy against the Club or the Committee. The Member shall not be entitled to any refund of Entrance Fee, Subscription or any other monies levied upon the membership for a specific purpose. In addition, a Member expelled or who resigns shall forfeit any right in and claim upon the Club and its property.

Subscriptions, Entrance Fees, and Other Fees

The current rates of subscription, entrance fees and reduced rates for the various categories of membership shall be determined by the General Committee. Any proposed change in the rates shall be notified on the Club notice board not less than 60 days before 1st March.

A reduced subscription, which will be reviewed annually, shall apply to a Seven Day Member, upon notification by such member, who completes fifteen continuous years of Seven Day Membership and reaches the age of sixty-five years and over. This reduction will continue for such members who subsequently revert to Five Day Membership.

The Club's subscription year begins on the 1st March and ends on the last day of February. Members joining during the current year shall pay a pro rata subscription.

Subscriptions must be paid in advance and no later than 1st March.

Members resigning or ceasing their membership for any reason during the subscription year of March 1st to February 28th will **NOT** be entitled to any pro rata refund of subscription paid. Members resigning who use credit facilities to pay for membership subscriptions will be strictly liable to pay Ashford Manor Golf Club the remaining subscription balance in full.

If you are unable to use the Club for any reason, subscription fees cannot be deferred, or refunded.

Any joining fee paid are non-refundable and non-transferable.

Members may not exercise any rights to the amenities of the Golf Club until the annual subscription is paid. Should the annual subscription remain unpaid at 1st April, the General Manager, after giving one month's notice in writing by both post and email, will post notice that the membership has ceased.

Any member who ceases to belong to the Club for any reason shall have no claim upon or be entitled to participate in any effects or property of the Club.

Newly elected members shall not be entitled to the privileges of the Club until their subscription and entrance fees are paid. Should such fees remain unpaid one month after notification of election, their election shall be null and void.

Visitors

Members may introduce visitors into the Club House on such terms as the General Committee from time to time may determine, provided the members accompany them. The members concerned will be responsible for the visitor's conduct whilst at the Club.

Subject to any restrictions which may be imposed by the General Committee, the following persons shall be entitled to admission to the Club premises to purchase alcoholic beverages:

- (a) Members' Guests and visiting golfers on payment of the appropriate green fee in advance of play.
- (b) Those golfers within (a) above taking table meals at the Club premises.
- (C) Those attending any function at the Club within the terms specified in the Club Premises License
