Notice of the meeting was taken as read on the proposition of Jane Perks, seconded by Ian Hunt. The proposition was passed unanimously by the meeting.

The President suggested that this be taken as read and included in the minutes.

This was agreed by the meeting.

# MINUTES OF THE PREVIOUS ANNUAL GENERAL MEETING

It was suggested that the minutes of the previous AGM held on 25<sup>th</sup> March 2022, be approved by the meeting. This was proposed by Howard Gill, seconded by Johnny Yates and the motion carried unanimously.

The minutes of the meeting were duly signed by the President.

# MATTERS ARISING FROM THE AGM OF 25<sup>TH</sup> MARCH 2022 There

were no matters arising.

#### TREASURER'S REPORT AND APPROVAL OF THE ACCOUNTS

The Treasurer, Glyn Isaac, presented the following report for the financial year ending December 31<sup>st</sup> 2022.

'President, Captains, Ladies and Gentlemen,

The Club has finally emerged from 2 years impacted by Covid restrictions to some degree or another. 2022 saw us operating for a full year but we have been challenged by the cost pressures facing all businesses and individuals at the moment – the club results have, of course, been impacted by these but show a reasonable set of figures and a strong cash and balance sheet position remain.

The Club's Net Assets increased by £18,004 to £957,241 accounted for by:

- a deficit for the year of £8,651
- a net increase in the Capital Reserve of £26,655

The Club generated cash for the year of £46,373. Capital expenditure totalled £47,025, of which £30,000 was for the Trilo 3 vacuum sweeper, £15,600 for the Kubota utility vehicle and £1,425 for some smaller items. The vacuum sweeper was funded through hire purchase finance with the other items paid for outright.

An inflow of £20,563 was created from working capital, with the key items being:

- -£26k increase in debtors- just a timing issue around year end.
- +£46k increase in subs paid in advance- there was a system problem with Club V1 in December 21which meant this figure was unusually low last year.
- +£16k increase in trade creditors again just a timing issue around year end.
- -£8k decrease in Sundry Creditors as the rates relief grant has been fully utilised.

We have now generated £139,000 towards the repayment of Members' Loans in 2026 (£1000 has been repaid during the year). This is £20,000 ahead of schedule and is held separately from General Funds.

The increase in Creditors due over one year is mainly due to the hire purchase agreement taken out on the Vacuum sweeper.

Subscriptions showed a strong increase of £26,412 with increases in all playing categories apart from a minor reduction in the non-playing category.

The Income and Expenditure Account emerged in reasonable shape with the club returning to a full year of operations following Covid led closures in part of both 2020 and 2021.

Entrance fees have grown strongly with 20 full playing members being admitted this year (13 men and 7 ladies). We are fortunate that our pipeline of prospective members also remains in a strong position.

Bar wet and dry sales have both grown strongly, with wet sales at £147k and food sales at £136k- well ahead of last year (Covid affected) and exceeding our budget expectations. We are fortunate as a club that our members support these two areas so well. Margins in wet sales are similar to last year and in line with budget; dry sales margins are down a bit on last year and against forecast and reflect our decision to hold back price rises to May of 2022

Course Expenditure increased to £244k, an increase of £19k from 2021 -course expenditure reduced slightly to £58k with less expenditure on the new hole development. Main areas of increase were in wages £6k- inflationary and as budgeted; machinery repair costs- up £4k-couple of major repairs needed; fuel up £5k- higher prices; depreciation up £4k- new assets acquired last year and this year.

Clubhouse expenditure increased significantly to £206k -up by £55k from last year- the main increases are in wages (£30k increase)- we have been hit by the same problems as many hospitality industries in hiring and keeping staff- staff churn has been high and pay rates have been increasing. The other main increase (£24k) has been in electric and gas costs — last year was artificially low as we were closed for 3 months but none the less, we have been hit like everyone in this area (we are, at least, in 2-year contracts with fixed prices so costs should stay the same for 2023)

Administration costs increased by £7k to £51k. Rates have increased by £5k – still at low levels historically but most of last year was at nil. Card process charges have increased by £2k as more and more transactions at the club are via card payments.

In total, controllable expenditure increased by £81k to £501k- this on the face of it is an exceptional increase and well ahead of budget (£470k) but the main elements (bar staff wages and utility prices) have impacted pretty much all businesses in our field.

Non-recoverable VAT has reduced slightly and although costs have increased the proportion recoverable has increased slightly due to our growth in bar and food sales.

The outcome for the year was a surplus of £18,004 prior to transfer to the Capital reserve which is a reduction of £18,886 from last year. This is I believe a respectable result given the cost increases we have suffered in pretty much all areas of our business (utilities, wages, fuel, food, and drink costs to name the major constituents). We are, as ever, indebted to the club officers, staff and our members for the support given to the club during the year.

Also, a big thank you to Clare Withey who has taken over the role as assistant Treasurer — (not sure she expected to stand in for me for a month when I was missing in action) - she has picked up the role seamlessly from Louise and deals with all our suppliers and making sure they get paid. And finally thank you to Janet Grant, who deals with everything regarding the monthly payroll process.

I am pleased that we have a good set of figures to present to the members. Although we have suffered an overall small deficit for the year, we have ridden out the worst of the cost

increases impacting most businesses, without having to increase members costs significantly. We have an engaged membership who use the club and its facilities regularly, plus a healthy waiting list of new applicants. Our balance sheet is strong, and we continue to grow our cash and we are well placed to repay the loans to members in relation to the Club redevelopment. I believe we are in good shape for 2023.

These accounts have been prepared to provide members with a comparable view of the golf club between 2021 and 2022. The official accounts for Hale Golf Club Ltd will be filed with Companies House with just a balance sheet at 31 December 2022 which will be the same as the balance sheet shown on Page 10 of the accounts. '

There being no questions for the Treasurer the motion to approve the accounts was proposed by Robin Holden, seconded by Paul Gilbert. The motion was carried unanimously.

On behalf of the membership the President thanked the Treasurer and the Treasury Team for all their hard work, recognising the incredible amount of work that has been done and the changes required now that HGC is a Limited Company.

#### SECRETARY'S REPORT & UPDATE ON STANDING COMMITTEES

The Secretary Vicky Chamberlain, gave the following report,

'President, Captains, Ladies and Gentlemen,

2022 was a very busy year for HGC Ltd. We started off with a much smaller Council (Board) of 9 people. Ably chaired by Roger Sheen we have managed to get through a significant amount of business.

The Treasurer has given us his report and it falls to me to tell you what else your Council has been up to. The best place to start is with the course itself. The new Par 3 was duly finished and opened, the course re-measured and new cards printed. Just as we were all getting used to the new numbering, unfortunately the new hole had to be closed due to the development of thatch and drainage problems. All agree that this is a very attractive hole and after a lot of hard work by our Green keeping team it is hoped that it will reopen within the next few weeks. Changes have been made to various bunkers, tee boxes & greens maintained, paths have been up graded, trees have been managed all with the intention of making this one of the best 9 hole courses in the North West. Greens and Council have also had to deal with the sink hole now filled and the loss of our trees next to a neighbour's boundary. The replacement planting of mature shrubs and trees looks very attractive. Our course is maintained to a fabulous standard. Much golf has been played, competitions won and lost, some by that most frustrating of results – a card playoff. Even I managed to win one Ladies comp this year, not a major but I will take them where I can get them.

The return of TNC, Ladies Tea, FNC and other staples of our club life have made a welcome return on a permanent basis. Hurrah, I hear you say. I am sure I speak for us all when I say how great it is to be together again as a Club with no restrictions. A full Social Calendar was delivered by our social committee with gourmet dinners, a Summer Ball and some excellent Christmas celebrations to name but a few. Bridge is back, with club and match bridge in full swing. I would like to thank Robin and Sue Holden, Jan Ravenscroft, Gill Kay and Chris Wood for organising the various bridge events. The annual Quiz night hosted by John Gower-Jones, Andrew Kay and Jim Mossop was great fun although Jim's eclectic sport knowledge had several of us stumped!

A long overdue overhaul of the Cottage has been a major project over the winter with Ben and his family moving into temporary accommodation for the duration. The other large project is the extension of the patio, currently underway, to make a much larger outside area for socialising. I look forward to spending much time on it this summer.

Membership remains healthy, with 38 Juniors, and 470 full members of which are 163 Ladies and 307 Gentlemen. We have had a steady stream of applications during the year in all categories and I hope all our new members feel welcome and are settling into the club. There remains a delay in being able to accept Gentleman members, but this is gradually improving.

I would like to thank all members of the Secretariat, especially Robin Russel-Fisher for taking the minutes at Council Meetings as well as supporting me in my role. You will notice that the office is looking much tidier and Robin and I with, help from Jo Egerton, have managed to have a good clear out. There is still a bit to do so that we can also use this as a meeting room when the club is busy. Ian Hunt, my guru for IT, deals with my difficulties with speed and patience. Ian, I thank you. David Swales and I enjoy our annual billing get-together in November, nothing stronger than coffee is imbibed, as we send out our requests for your money. I would also like to thank Chris Wood and Rosie Gerard for continuing as our archivists. I will be getting the new Club Handbook sorted over the next few weeks and I thank Tiff Fielden for her ongoing support in ensuring we get it printed.

I had hoped this year would be more straight forward than last year, but it has thrown up its challenges, the worst one being my struggle with long COVID and a brain that had turned to mush. As I did last year, I have to thank you all for your support and commitment to the club, we are only as good as our members and I think we are very good indeed. This concludes my report.'

There being no questions for the Secretary the motion to approve her report was proposed by Irene Kirk, seconded by Freda Hunt. The motion was carried unanimously.

The President thanked the Secretary for her report, recognising the time the job takes and the wide scope of duties involved.

#### **LADY CAPTAIN'S REPORT**

The Lady Captain, Judy Pinnington gave the following report:

My last big thank-you must go to my husband, Ian. He has been my tower of strength and I do not think that I would have enjoyed the role so much without his continued support. He can now step down from his job as Uber-Man and return our family to normality.

Finally, I should like to take this opportunity to offer my best wishes to the new Captains, Roger and Jan for their year ahead. Hale is a special club and I am sure they will receive the same loyalty and support that the Gentleman Captain and I have enjoyed.'

## **Gentleman Captain's Report**

We are very lucky to have them. And if you need to be reminded what a great family this is, I saw John Webb this week, I spoke to him, today, on the phone and this club has kept this man going. He is the most stoical person I think I have seen. Everyone in this room sends him their best

wishes. Many have been to see him, written to him. It's a hard illness he is going through but it's this club that keeps him going, so we should be very proud of that.

Finally, I'm not in this for a long time, I'm in this for a good time. I'm not going to be captain for a long time, I'm going to be captain for a good time, and I think if I am having a good time, you'll have a good time. If I am standing here in 12 months' time and there are as many people in this room smiling as there are now, I will know I have done a great job. Thank you'

#### **ELECTION OF OFFICERS AND COUNCIL MEMBERS**

Election of all the directors to the board and the deputy directors for the various committees were then made.

The nominations for all officers except the President were dealt with first.

None of these nominations for Directors or Deputies were contested.

I would remind you that I was appointed President in July 2021 for a two year term of office and that 2 years will come to an end when I hand over to John in July (assuming of course that he is elected!) Having given the background It is my great pleasure to move onto the election. John is a very enthusiastic and popular member of our Golf Club.'

# Minutes of the Extraordinary General Meeting, held on 18<sup>th</sup> September 2023 at 7pm in the Clubhouse

The President, Barry Jefferies, opened the meeting by welcoming all those present and thanking them for attending.

The notice of the Meeting was read by the Secretary.

2 information meetings regarding the proposed irrigation project had been held prior to the EGM. and overview of the details was circulated with the Notice of the meeting.

The meeting was opened to questions:

David Swale asked where the club stood on cost & payment for the project. Glyn Isaac (Treasurer) informed the meeting that the quote of £350 K would be made up of gifts and donations from the members. The proposed amounts being £300 in gifts/loans with the remainder, £50K, Capital Funds.

Andrew Hay (Project Leader) highlighted the contingencies that had been built into the quote to cover inflation and usual contingency for any project this large.

Peter Harden queried if the current outstanding loans for the clubhouse project would be repaid before new loans for the Irrigation project were raised. Glynn Isaac confirmed this would be the case. To consider and, if thought fit, to pass the following resolutions, which will be proposed as ordinary resolutions:

There being no further questions the President ask the Secretary to read out the Ordinary Proposition to be voted on:

- 1. THAT, the Council of the Company (or a sub-committee duly appointed by the Council) be empowered to proceed with the implementation and installation of a new irrigation system on Hale Golf Club's golf course, details of which were presented to members in August 2023(the "Project"), subject to:
  - a) the cost of the Project not exceeding the sum of £350,000 (the "Cost");
  - b) the Cost having been covered by accrued funds of the Company, donations and/or Members' loans before the Project contracts are entered into by the Company; and

- c) there being no borrowings incurred by the Company in relation to the Project, other than by way of the Members' loans.
- 2. THAT, the Council of the Company be authorised to borrow, by way of interest free loan from Members, funds to finance the Project not exceeding the Cost.

The President then summarised the position and stated that he proposed to ask members to vote by raising their hands. He reminded all Members that only Full members, Honorary life members and Non-playing members who have held full membership for at least 10 years are eligible to vote.

For the resolution to pass a 2/3 majority of those people attending and voting tonight is required. If the outcome appeared to be in doubt then he would resort to a paper vote.

Both parts of the resolution was passed unanimously by a show of hands.

The President thanked the attendees and the meeting was closed at 7. 48 pm
