1. Introductory Statement of Intent:

It is the intention of the members and directors of Whiteleaf Golf Club Limited (“WGC”) that any member of the club or visitor to the club that requires the use of a buggy to play golf is afforded every opportunity to continue enjoying their golfing experience at WGC.

However, the safety of all members, visitors, staff and general public is of paramount importance and therefore the following Policy contains the conditions and, where appropriate, the restrictions imposed by WGC on users of buggies.

The legal duties imposed on the club only apply to those members, visitors or guests of the club who are disabled, within the meaning of The Equality Act 2010, and who cannot play golf without the use of a buggy (for further definition refer to the ‘Club Duties, Health and Safety’ Section 3 below)

2. Policy Introduction:

The following Policy has been prepared using guidelines and published advice from the English Golf Union (“EGU”) and National Golf Club Advisory Association (“NGCAA”). Furthermore, this Policy and Hole-by-Hole Risk Assessment applies to all persons intending to use ride-on buggies on the course or grounds; that is any member of WGC, visitors to WGC and all staff and volunteers at WGC.

WGC does not presently own or operate any of its own buggies so this Policy refers only to recognised 4 wheeled single seat golf buggies, which must be manufactured to The British Standards Institution accredited standards. WGC does not permit the use of three wheeled buggies or golf carts that carry more than one person. All references to buggies throughout this Policy means only those buggies specified above, that is a 4 wheeled single-seat ride-on buggies.

WGC recognises that a public right of way crosses the golf course whereby all buggy users must give priority right of way to all users of this public footpath.

Throughout the policy, all risks identified are categorised as ‘high’ risk to the buggy user and any other player, visitor or public using the course.

There is a reasonable assumption that all persons using buggies on the course are potentially at risk in respect of each of the risks identified within this Policy.

WGC does not bear any cost incurred by the user with any buggy.

Course damage is another key feature that is considered. During the winter months the course applies pedestrian traffic control on several holes to minimise wear and ensure safe passage. The Sports Turf Research Institute (“STRI”) has provided guidance to the EGU on course wear and damage under all conditions. Their recommendations have been included in the Hole-by-Hole Risk Assessment and cover traffic flow, spread, wear and what, if any, actions can be taken to minimise risk to individuals and course.

This Policy does not currently recommend the design or introduction of a dedicated buggy path. This has been excluded on the basis that the cost of such a path throughout the course will be prohibitively expensive, that it would absorb too much playing surface and that it will not overcome topography that identified as high risk.

In summary the following conditions will apply:

- (1) The user understand that paths are not provided and certain areas of the course are inaccessible by buggies
- (2) Responsibility rests exclusively with the user and they will be required to sign a Golf Buggy Safety Acknowledgement Form to this effect
- (3) At the discretion of the Club General Manager or their approved nominee, no access is permitted in weather conditions that are deemed hazardous, such as wet or frosty ground conditions

- (4) Access to the course itself is through the side gate (on Golf Club Lane behind the cricket pavilion). This gate is padlocked using a RADAR lock and a key can be obtained from the clubhouse if required. The entrance gates near the professional shop are deemed to be at an inappropriate point to permit access to the course (see 'Hole-by-Hole Risk Assessment' Section 5 below). No special parking arrangements are available and care must be taken unloading a buggy at any point on Golf Club Lane
- (5) The user accepts that this Policy relates only to on-course traffic and use of ride-on buggies and does not extend to cover access to the professional shop, the changing rooms or the clubhouse

3. Club Duties, Health and Safety:

The legal duties imposed upon WGC in the Equality Act 2010, Section 6 Disability, only applies to those members, visitors and guests of the club who are disabled within the meaning of the Act and who cannot play golf without the use of a ride-on buggy. The club is therefore free to formulate whatever policy it so wishes for non-disabled golfers.

This Policy therefore requires any disabled golfer, as defined above, to adhere to the Policy in full and it is the club's preference that any non-disabled golfer does not use ride-on buggies for their golfing experience at WGC. Should a non-disabled golfer insist on using a ride-on buggy, they too will be bound by the conditions contained within this Policy.

Furthermore, in respect of health and safety, the club has a duty of care to users of ride-on buggies and has therefore:

- Conducted an on-course hole-by-hole risk assessment.
- Identified remedies to minimise or eradicate any risk and considered any reasonable adjustments that are needed to enable disabled people to access the course and facilities
- Instructed an independent Health and Safety Consultant to complete a site visit and review the clubs existing policy and risk assessments.

WGC has also applied restrictions to sensitive areas of the course, taking consideration of material published by the STRI, to minimise the damage to the course under dry, wet or frozen ground conditions and this Policy includes possible risks from those affected areas.

5. Section a: Use of Ride-on Buggies on the Golf Course

Use of a ride-on buggy will not be permitted unless authorised by WGC and will be restricted to members, visitors and guests demonstrably having a genuine incapacity to play golf unless aided by the use of the buggy.

Any person who operates a ride-on buggy on the golf course is deemed by so doing to have the knowledge, training and skill to safely operate their vehicle and be fully accountable for their actions and the consequences thereof. The safe operation of ride-on buggies on the course requires the conscientious application and adherence to the minimum standard of care prescribed by this Policy.

Ride-on buggies must be operated in accordance with the requirements of the following sections of this Policy:

- Golf Buggy Safety Policy
- Golf Buggy Safe Working Practice
- Golf Buggy Safety Policy Acknowledgement Form

In order that these conditions can in practice be met, the Club General Manager or their approved nominee must be given prior notice of a requirement by a member, visitor or guest to use a ride-on buggy.

WGC reserves the right to refuse permission if some or all of the conditions stipulated are not complied with and from time to time WGC staff may determine that the state of the course or the weather is such that safety on, or the condition of, the course may be unacceptably compromised if a ride-on buggy is used.

During general (non-competition) play a ride-on buggy shall only be used by those authorised to do so in accordance with this Policy. Regrettably WGC cannot permit ride-on buggies to be used during open or closed competitions as some parts of the course are deemed inaccessible by buggies.

6. Section b: Golf Buggy Safety Policy

WGC has a duty of care to all users of the golf course. The topography of certain areas of the course is such that caution and prudence must be shown at all times. It is also necessary for WGC to provide adequate safe means of access for all golfers including those given permission to use buggies. Moreover, the club has to ensure the safety of golfers who do not wish to use ride-on buggies but who might be at risk from a mechanically defective buggy or its careless use. This duty of care also applies to members of the public using the various rights of way.

To assist with the safe employment of ride-on buggies all potential users shall comply with the following conditions:

1. Ride-on buggies at WGC are only for the use of members and visitors who are disabled within the meaning of the Equality Act legislation
2. Ride-on buggies must be operated with the utmost courtesy, care and consideration for the safety and convenience of pedestrians. Pedestrians must be afforded the right of way at all times
3. Any signs and instructions employed on the course to warn buggy riders of potential danger areas or areas forbidden to use ride-on buggies because of concern about danger or the potential to cause unacceptable wear and tear to the course must be followed at all times
4. Ride-on buggies must be operated and parked in such a manner that they do not impede or interfere with normal pedestrian or vehicular flow on roadways, ramps or pavements
5. Ride-on buggy operators will be responsible for the security of ignition keys for the period that the buggy is on the property owned by WGC
6. WGC has no responsibility for ensuring the safe operation of ride-on buggies on or beyond the confines of the course and the club car parks other than those operated by their staff or agents. WGC will not accept responsibility for any loss or damage caused to any property other than that arising from the negligent use of a ride-on buggy by an employee
7. No ride-on buggy will be operated in excess of 10 mph and all speed limits must be observed
8. Ride-on buggies shall be used only between dawn and dusk
9. Ride-on buggies must be operated in compliance with the common 'rules of the road'
10. Operators must stop the buggy at blind intersections and proceed with caution
11. The consumption of alcohol and / or the improper use of drugs is not permitted when using the ride-on buggy
12. No buggy can be recovered from the course due to damage or power / fuel failure out of normal club operating hours and the user is not permitted to use other vehicles to recover their buggy. In such circumstances they must notify any club official on site or wait until the club professional opens again. Any cost incurred by the club in recovering a buggy will be the responsibility of the user
13. The Club General Manager has the authority to immediately prohibit any individual from using or being carried on a buggy

7. Section c: Safe Working Practice

- Ride-on buggy operators must not be under the influence of alcohol or drugs
- Children are not permitted to drive the ride-on buggy at any time
- Before use all operators of ride-on buggies must sign the Safety Policy Acknowledgement Form before they are allowed to drive the buggy
- A ride-on body shall only be used for the number of occupants it was designed to carry and only by people who are authorised to use one
- During use do not move off until the occupant(s) are seated
- Always remain seated and hold on while the vehicle is in motion
- Hands, feet and head must be kept inside the buggy if relevant at all times while the vehicle is in motion
- Ride-on buggies must not be driven in prohibited areas
- The vehicle must be used to progress the game and must not be driven up and down excessively, for example when looking for golf balls
- The vehicle must not be used on tees or greens or any slope leading up to them
- The vehicle must not be used within two metres any bunkers, ditches, ponds or any slope leading to them except when using any designated bridge or path
- Check the area behind the vehicle before reversing
- Set the parking brake before leaving vehicle
- Always consider the terrain and pedestrian traffic conditions as well as environmental factors that may affect your ability to operate a vehicle safely
- Drive the vehicle only as fast as the terrain and safety conditions allow to avoid tipping over
- Drive the body straight up and down slopes
- Slowdown before corners
- All turns must be executed at reduced speeds
- Avoid sudden stops or changes of direction that may result in loss of control
- Be extra careful when the course is wet and muddy
- After use when the vehicle is left unattended turn the operating key to the off position, remove the key and engage the parking brake

8. Section d: Golf Buggy Safety Acknowledgement Form

All golfers must complete this form prior to operating a buggy

Any person who operates a ride on buggy at Whiteleaf Golf Club Limited ("WGC") is deemed, by so doing, to have the knowledge, training and skill to safely operate the vehicle and shall be fully accountable for their actions and consequences thereof.

The safe operation of ride-on buggies requires conscientious application and adherence to the minimum standard of care prescribed by this Policy.

Users of golf buggies do so at their own risk. WGC will not accept any liability for any loss or damage to the golf buggy or any other property other than arising from the negligence of the club or any of its representatives or agents.

4. Section e: Checklist for Users of Ride-on Buggies

This section is designed to ensure all buggy users confirm they are acquainted with the operating controls of their own buggy.

Know the controls and how to use them (where applicable):

- Ignition switch and immobiliser key
- Accelerator
- Footbrake
- Parking brake; which must be set before leaving the buggy
- Reversing control

Know your driving conditions:

- Ride-on buggies can only be used for the number of occupants it was designed to carry and by those authorised to do so
- Ride-on buggies must not be used on the areas of the course where prohibited
- The vehicle must not be driven up and down the course when looking for golf balls
- The vehicle must not be used on tees or greens or the slopes leading up to them
- The vehicle must not be used within two metres of, or on the slopes leading to, any bunkers, ponds or ditches (accept at designated crossing points)
- Always consider the terrain, existing vehicular and pedestrian traffic conditions, as well as environmental factors that may affect your ability to operate the vehicle safely
- Drive the vehicle only as fast as the terrain and safety conditions allow
- To avoid tipping over drive the buggy straight up and down severe slopes
- Slowdown before corners
- All turns must be executed at reduced speeds
- Avoid sudden stops or changes of direction that may result in loss of control
- Be extra careful when the course is wet and muddy

5. Appendix 1: Hole-by-Hole Risk Assessment:

The following Risk Assessment applies to all persons using ride-on buggies on the course namely, members, visitors to the club and also to any staff members or agents.

WGC recognises that a public right of way passes through the course and that pedestrians have priority on the path.

All risks have been categorised as 'high' given the unique topography of the course.

There is a reasonable assumption that all persons using buggies on the course are potentially at risk in respect of each of the risks identified within this Policy.

It should be noted that WGC is a nine-hole course and therefore each reference to a specific hole applies equally to whether it is classed as front or back nine (for example hole 1 and hole 10).

‘THE LOOP’

Holes 7, 8 and 9 (16th, 17th and 18th) are collectively known as ‘The Loop’. Geographically, the holes are in a cluster at the far side of the golf course as viewed from The Club House. The holes are effectively on a raised plateau, with the 7th and 9th fairways transgressing slopes up (7th) / down (9th) the raised area. The whole of the 8th hole is on the highest part of the plateau.

The current topography of ‘The Loop’ could allow the 7th and the 8th to be played by players using a buggy, subject to the hazard / risk comments identified in the risk assessment on Page 16. However, this would be subject to players using the 7th fairway, rather than the 9th, to return to the lower areas of the course.

Unfortunately, the slope of the 9th fairway in the final yards before reaching the practice area is too steep to be deemed acceptable for buggy use. Therefore, use of buggies on the 9th hole is currently prohibited.

Because the 9th hole is not suitable for buggy use, and that the 7th fairway would have to be used when moving back to rest of the course, buggy users are prohibited from playing or accessing the three holes that collectively make up The Loop.

‘THE LOOP’

Although ‘The Loop’ is prohibitive to buggy users, each hole has been individually assessed as follows:
